The processing of personal data takes place in the following activities:

Marketing

Purpose of processing:

Performance of the contract and execution of pre-contractual measures in accordance with Article 6 (1) (b) GDPR.

Description of purpose of processing:

Your personal data are used for the marketing purposes. These purposes include mainly the following processing activities:

- efficient communication relating Origameo services and offers,
- ensuring examination of a complaint or claim made by you,
- carrying out our obligations and enforce our rights arising from any contracts entered into between you and us,
- notifying you about changes,
- your e-mail address or phone number can be used by HB Reavis to inform you about Origameo activities,

The conclusion of the contract and to organize marketing activities is possible only if we can process your personal data. In case that the personal data are not provided, our company will not be able to enter into the contract with you.

Authorization to process:

We process personal data based on pre-contractual measures.

Processing time:

As soon as HB Reavis no longer needs your personal data for the processing purposes for which the personal data were collected, it will delete them unless the statute-barred period applies. Certain details and correspondence may be retained until the time limit for claims, in respect of the pre-contractual or contractual relationship has expired or in order to comply with regulatory requirements regarding the retention of such data.

What are your rights?

You have the following rights to process your personal information

- Access to personal data we process about you.
- Rectification of incorrect or inaccurate personal data and add incomplete personal data.
- Restriction, i.e. blocking of processing of your personal data.
- The deletion of personal data in case the purpose absence or unauthorized data processing.
- Submission of an objection to the processing of personal data if you believe that our data processing is not justified.
- Be excluded from automated decision making.
- Listing of personal data in a structured and machine-readable format or for another controller.
- Revocation of consent to the processing of personal data.
